The vacancy is within the Directorate Health, Consumers and Reference Materials. The directorate provides independent scientific evidence for the development, implementation and evaluation of EU policies, mainly in the areas of standardisation, public health, food and feed safety and authenticity, cosmetics and other consumer products, medical devices, nanomaterials, taxation with a focus on frauds and a well-functioning internal market.

The operational scientific research will take place in the unit Consumer Products Safety.

Short description of activity:

The main activity of the ER Project PIRAT relates to the development of a biochip device allowing the evaluation of immunogenicity of advanced materials in full blood.

The successful candidate will be in charge of:

- The development of a microfluidic based device enabling the testing of different materials such as liposomes, bioand nanomaterials;
- The optimisation of immunoassays (e.g. bioreceptor immobilisation) for detecting e.g. complement activation markers in full blood. The immunoassay will be first developed on a surface plasmon resonance instrument;
- The evaluation of the relevance of inter-individual variations of immune responses in order to contribute to ongoing discussions related to the standardisation of humanised immunogenicity in vitro tests.

Qualifications:

- Completed university studies of at least three years attested by a diploma and at least five years professional experience in a field relevant to the position, alternatively a doctoral diploma in biology, biochemistry or physics or related field;
- Knowledge of immunoassay development is essential;
- Knowledge of immunogenicity, surface plasmon resonance technique and microfluidic device
